## 8. Downtown Streetscaping Update for the BIA re: Committee of Council Report – May 31, 2017 (9:20 – 9:30 a.m.)

- Previous board meeting mentioned that the presentation of recommendations would be presented at the AGM.
- The formal presentation to Council was on May 31 and is a very exciting project for the downtown core.
- The BIA and local public can build on the work from the past and also a more accessible walkable and pedestrian friendly downtown.
- R. Evans details the letter that was passed around.
- Discussion arose on some concerns included commercial delivery and pick-up, resulting in utilization of the laneways
- Diplock Lane was mentioned as an alternative for additional parking as the total loss of parking is only 5%.
- The overall project will be a 2-year construction project, first with the essential water main replacement, and then the streetscaping. The next step would be to then hire a consultant.
- R. Evans mentions that the budget is \$25 million as detailed in the Committee of Council proposal, however, is tentative as it has not been passed yet.
- Discussion arose on who is in downtown and those that are simply passing by, resulting in those passing by being the biggest majority are not customers of downtown.
- B. Darling presents a rendering of the planned recommendation and mentions the need of bike lanes to connect the downtown.
- H. Custodio recommends having a pilot program.
- S. Godefroy will be writing a letter back to B. Darling and will be sent ASAP and will bring the board up to date.
- All suggestions should go to Council as there will be one meeting before the summer, however, Councillor Moore mentions that there was a motion to have a meeting tentatively scheduled for August 9, 2017
