- S.Godefroy confirmed that Z. Majid had made the amendment to the budget, and that the In- Kind Service request was specifically for the summer event support.

- The Downtown Brampton BIA had a safety forum on July 12th, 2018 discussing the events that happened this past June & July.
- BIA has booked Safety workshops with the PRP for the fall.

- S.Godefroy and P. Aldunate attended a Brampton Board of Trades meeting, where P. Aldunate gave a presentation on all of the projects happening in Downtown Brampton. S.Godefroy would like to get the same presentation for the BIA board members. In the near future.
- Brampton Entrepreneur Centre is partnering up with Ryerson University to create a pilot innovation hub.
- DBBIA is working on the upcoming Holiday and Christmas beautification plans with H. Custodio and the beautification committee.
- Community Sponsorship for 2019 The DBBIA will be issuing a public notice to all community partners regarding the request for sponsorship proposals. The deadline will be January 31st, 2019.
- Working with marketing committee to create the Holiday edition of Discover Downtown Brampton.
- Gift card program with Anycard on hold.
- The BIA will be changing up the shopping bags to feature the Christmas season.
- Farmers' Market has been extended to October 6th, 2018 (Thanksgiving Weekend.)
