7. Financials: Budget 2018-2021 (9:10 – 9:20 a.m.)

- The 2020 budget is in progress and will host some public workshops for the membership.
 - Budget workshops will be communicated to BIA members via email and the website.
- The first draft is to be submitted by mid August for 2018-2021 (three years).
- Overall, the DBBIA is not looking to increase the levy.
- Budget workshops will be communicated through the BIA members via email and the DBBIA website.

8. Downtown Streetscaping Update (9:20 – 9:25 a.m.)

- Following the previous Board meeting on June 20, a number of action points have been acted upon back to City staff, particularly to Bob Darling.
 - o This included a letter that was sent and emailed regarding the streetscaping.
- Discussions included the marketing, communications, and business concerns with loss of parking.
- Since then, Anthony Wong has been the lead on discussing concerns with the businesses.
- The A-frame issue was also mentioned and the bike lane proposal.
- Discussions included a quick fix of some issues including parking signage, the cleanliness, lighting to utilize the parking garages, as well as safety.
 - Follow up walk about to be conducted and fixed with the DBBIA Parking Garages.
- R. Evans had a meeting yesterday with Engineering on the removal of street parking.
- The focus is not on removal of streetscaping, rather the redevelopment of downtown.
 - Even with a petition that has been distributed, the streetscaping is an opportunity not to be missed.
- A. Wong has met with more than 30 businesses and based on the small sampling, 60% prefer the pedestrian friendly downtown.
- A project drop-in centre will be set up in September and will showcase how the streetscaping will appear and a mock up.
- Councillor Medeiros suggests if a public meeting can be scheduled, similar to a town hall, which will be arranged at the new drop-in centre.
 - Status date to be selected.

10. Display of Wares & A-Frames (9:30 – 9:35 a.m.)

- Regarding the Motion to ask the City to have A-frames under the Display Wares program.
- S. Godefroy spoke with Bob Darling, who discussed with Legal, and then made a delegation to Council on July 5, 2017.
- Council made a resolution the same day and are going to meet very soon to see how A-Frames can be implemented as quickly as possible.

11. Farmers' Market (9:35 – 9:45 a.m.)

- In the past, BIA businesses participated at no cost. 21 businesses were interested, however, only with 15 spaces available.
- Focused in on Main Street due to business disruption.
 - One business in particular has 4 spaces, while others chose not to participate due to the new fee.
- Councillor Medeiros heard feedback from Queen Street West, particularly on how they are BIA businesses and the market has not expanded in their area.
- Overall, the BIA feels that the Farmers' Market should stay downtown, however, requires better planning with the City of Brampton and the DBBIA.
